
**STANDING ORDER**

**WHEREAS** the Middle District of Pennsylvania has established an Alternative Dispute Resolution Program in which individuals named on the court's list of certified mediators (attached) serve as pro bono ADR neutrals; and

**WHEREAS** the court finds that its certified mediators have demonstrated that an exemption from payment of fees under the Electronic Public Access Fee Schedule is necessary in order to avoid unreasonable burdens and to promote public access to information,

**IT IS HEREBY ORDERED THAT** a PACER ID and password be issued to individuals named on the Middle District of Pennsylvania's list of certified mediators to be used solely in their capacity as pro bono mediators in the Middle District's ADR Program; and

**IT IS ALSO ORDERED THAT** individuals named on the court's list of certified mediators are exempt from payment of PACER fees in such accounts. They shall not be exempt from payment of PACER fees incurred in connection with other legal work
