

ORDER

THE BACKGROUND OF THIS ORDER IS AS FOLLOWS:

The Clerk of Court has created the attached spreadsheets which lists sealed miscellaneous cases that have had no activity occur within the past ten years. The Clerk's office prepared a letter to the U.S. Attorney's office notifying them of the status of those cases and requested a response as to whether they object to the shredding of the records contained within. The U.S. Attorney's office had no objections. The Clerk's office then prepared, for each judicial officer assigned to the cases, a proposed order directing the destruction of the records. Each judge signed the proposed order drafted on their behalf.

IT IS HEREBY ORDERED THAT the Clerk of Court is directed to remove and destroy the closed Miscellaneous case files listed on the attached spreadsheets that are presently located in the Harrisburg Clerk's Office vault at 228 Walnut Street, Room 1060, Harrisburg, Pennsylvania. Said cases shall be shredded in accordance with the Records Disposition Schedule in the Guide to the Judiciary Policy (Guide Vol. 10, Ch 6, § 650).
