STANDING ORDER

AND NOW, this 7th day of March 2022, it is hereby **ORDERED** that the findings and directives of Standing Order 2021-12 are **RESCINDED**. The Court continually reviews its operations to identify measures that will help protect Court employees and the public from the COVID-19 virus, while at the same time preserving its core mission of serving the public through the fair and impartial administration of justice.

The Court’s ongoing review of its operations includes the monitoring of guidance emanating from various authoritative sources relative to the administration of the federal courts. Integral to that analysis is the guidance promulgated by the Centers for Disease Control and Prevention (CDC) on February 25, 2022, which sets forth new COVID-19 community level metrics. These metrics consider county community data, such as hospital admissions and bed space, and the total number of new COVID-19 cases. Based on such data, the CDC has assigned a low, medium or high community level to counties to assist in assessing COVID-19 prevention steps, including masking requirements. As of this date, most of the counties that make up the Middle District of

Pennsylvania have received a MEDIUM/Yellow COVID-19 community level, which does not require indoor masking unless individuals are at high risk for severe illness.

IT IS HEREBY ORDERED, effective immediately and until further order of the Court, that:

1. This Order supersedes Standing Order 2021-12 entered on August 9, 2021.

2. The Court now suspends the requirement that all persons, regardless of vaccination status, entering the Ronald Reagan Federal Building & United States Courthouse in Harrisburg, Dauphin County; the William J. Nealon Federal Building and United States Courthouse in Scranton, Lackawanna County; the Herman T. Schneebeli Federal Building and United States Courthouse in Williamsport, Lycoming County; and the Max Rosenn United States Courthouse in Wilkes-Barre, Luzerne County, must at all times wear a mask or face covering in common or public spaces, including but not limited to, hallways, bathrooms, Clerk's Office public counter/intake area, Probation Office reception, elevators and stairwells, **except as provided below in paragraphs 3 and 4.**

3. The Judicial Officers and Court Unit Executives have discretion with respect to the implementation of additional safety protocols, including requiring masks in their respective chambers and offices. With respect to non-court

personnel, including GSA and the CSO's, masking shall be determined by their respective employing offices.

4. Mask requirements remain in effect for Jurors, Grand Jurors, and all those participating in courtroom proceedings.

5. Criminal defendants will continue to be required to have a negative COVID-19 test before being transported from a prison to the Courthouses.

6. Persons who are not fully vaccinated against COVID-19 are required to maintain six feet of physical distance from each other at all times when entering these federal buildings and courthouses and in common and public spaces, including but not limited to courtrooms, hallways, bathrooms, Clerk's Office public counter/intake area, Probation Office reception, elevators and stairwells.

6. This Standing Order shall be enforceable by the United States Marshals Service and the Court Security Officers.

This Order shall remain in full force and effect until further notice.
